BY-LAW 7, NUMBER 2 STATES THAT:

“Not later than two weeks before the date of the annual meeting, the Board of Directors will submit to the membership the slate of directors, officers, and representatives, as drawn up by the Chairman of the Nominating Committee. Ten members desiring to nominate another candidate as a director, officer or representative of the Society shall send to the Nominating Committee, at least one week prior to the annual meeting, a written nomination of such member, signed by each of them, together with a consent in writing signed by the candidate that she will accept office if elected or appointed. In this event a ballot will be taken at the annual general meeting; otherwise, the persons nominated by the Nominating Committee as directors, committee chairman and Society representatives shall be declared elected, and the Board of Directors shall, at its first meeting, appoint the officers nominated by the Nominating Committee or chosen by ballot at the meeting as the case may be.”
