1. Information Security & Confidentiality Obligations

As a volunteer serving McGill University, I understand that I have a legal obligation to protect any personal information and other kinds of confidential information (whether in written, verbal, electronic or other form) that I may receive or collect in the course of my volunteer activities (the "**McGill Confidential and Personal Information**"). I understand that the McGill Confidential and Personal Information includes personal information concerning individuals, confidential information about McGill University and its associated organizations and their members (such as the McGill Alumni Association, its constituent groups and branches, Friends of McGill, the McGill University Trust, and the Martlet Foundation of Hong Kong), as well as any other information otherwise marked or known to be confidential.

In accordance with the Act respecting Access to documents held by public bodies and the Protection of personal *information* (R.S.Q. c. A-2.1), and the McGill University Advancement Privacy Statement set out on Page 2 of this Volunteer NDA, I agree:

- (i) to store McGill Confidential and Personal Information in a secure manner to safeguard the contents from unauthorized disclosures;
- (ii) not to divulge McGill Confidential and Personal Information to another individual or organization, except with McGill University's express written consent;
- (iii) to use McGill Confidential and Personal Information strictly for the purposes for which it was collected, and only in relation to my volunteer services for McGill University;
- (iv) that all information I collect during my volunteer service to McGill University, belongs to McGill University;
- (v) that McGill Confidential and Personal Information shall remain the sole property of McGill University at all times, and that I shall return it at the end of my volunteer services, or at any time, upon request by McGill University; and
- (vi) that I have been made aware of the McGill University Advancement Privacy Statement and will abide by it and support McGill University in adhering to this statement.

2. <u>Security Incidents</u>

I understand that if I become aware that any McGill Confidential and Personal Information has been lost or shared in an unauthorized way, or of any other form of privacy breach, I am required to notify my McGill University Contact (identified below) or <u>security.dev@mcgill.ca</u> immediately.

3. Media Requests

I will promptly refer any McGill University-related media requests for information or statements to a UA staff member or the McGill University Media Relations Office, and will not reply to such requests on my own.

4. Effect of Signature & Survival of Confidentiality Obligations

By my signature I acknowledge that I have read and will abide by this Agreement. I understand that the obligations of this Agreement take effect upon signature and will continue even after my volunteer service to McGill University ends.
